Re: Polar Capital Funds plc (the "Company"),

Emerging Markets Income Fund (the "Fund").

Dear Shareholder,

We wish to notify you of a decision which has been taken by the Directors of the Company to propose to the Shareholders in the Fund that the Fund be merged with another sub-fund of the Company, the Emerging Market Stars Fund. Any such merger proposal will also be subject to the approval of the Central Bank of Ireland (the "Central Bank") and shareholders of the Fund.

This decision has been prompted by the recent announcement by the portfolio manager, William Calvert, of his intention to retire. William joined Polar Capital LLP in October 2010 and has managed the Fund since its inception in January 2011.

The merger, if approved, will result in the property of the Fund becoming the property of the Emerging Market Stars Fund in exchange for the issue of Shares in the Emerging Market Stars Fund to the shareholders in the Fund. Details of the share classes in the Fund are detailed at Appendix 1.

If approved by the Central Bank and shareholders of the Fund, it is proposed that the Merger will take effect early in the second quarter 2021. In the meantime, William will continue to manage the Fund as normal. A separate merger specific communication will be issued to shareholders in due course.

In the meantime, we have taken the decision not to accept further subscriptions into the Fund. However, redemptions and switch requests can continue to be placed in accordance with the provisions of the prospectus and the supplement for the Fund.
