NOTICE TO NOTEHOLDERS OF DETERMINATION OF POTENTIAL ADJUSTMENT EVENT

With respect to the Equity Linked Notes listed in Annex I attached hereto (the "Notes")

We refer to the Notes. Capitalised terms used and not otherwise defined in this notice shall have the meanings given to them in the Notes.

On 10 November 2020, Pfizer Inc. – ISIN US7170811035 ("**Pfizer**") announced a spinoff distribution of its subsidiary Upjohn Inc. ("**Newco**"). Immediately following the spinoff, Newco will merge into Mylan N.V. ("**Mylan**"), and the combined company will be renamed Viatris Inc. – ISIN US92556V1061 ("**Viatris**"). The distribution ratio is approximately 0.1247 of a Viatris share for each Pfizer share held. As result of the foregoing, Banco Bilbao Vizcaya Argentaria, S.A., in its capacity as Calculation Agent under the Notes, has determined that this event constitutes a Potential Adjustment Event in respect of the Reference Item of Pfizer in the Basket of Shares (the "**Affected Share**").

Pursuant to the terms of the Notes, we hereby inform that from November 17, 2020 (the "**Effective Date**") the Notes will be adjusted by the Calculation Agent as follows:

 For the purposes of any relevant calculation under the Notes, the RI Initial Value of the Affected Share will be multiplied by 0.94648827.

This notice shall be governed and construed in accordance with the same law applicable to the Notes.
