### Schroder ISF Emerging Europe Fund

As you are already aware, due to the extreme market volatility and suspension of share trading in Russia and Russian related securities, the calculation of the net asset value (NAV) and the issue, switching and redemption of all share classes in the Schroder International Selection Fund (ISF) Emerging Europe fund (the fund) was suspended with effect from 1 pm CET on 25 February 2022. The decision to suspend the NAV calculation was taken by the Schroder International Selection Fund board on 28 February 2022 based on a recommendation from the Management Company, and the NAV remains suspended until the Board is able to take the decision to reopen the fund in the interests of shareholders.

During the suspension period, the annual management charge (as well as other fees due under the prospectus) continues to be charged to the fund and we will continue to pay rebates in relation to investments in the fund due under the terms of the agreement(s) which you have in place with Schroder Investment Management (Europe) S.A. (SIM EU).

For the purpose of calculating these rebates, we will use an unpublished NAV for the fund. This will allow our rebates operations team to calculate and to pay rebates due within the timeframe specified in the relevant agreement(s).

Rebates will continue to be calculated on this basis until further notice.
