Please read this letter carefully as it contains important information regarding upcoming changes to the above funds.

In this letter, when we say 'we' or 'us', we mean Aberdeen Standard Fund Managers Limited, the company that is currently responsible for managing and operating your investment.

The list of funds in each of the Vehicles is set out in Appendix 1.

Changes to the Funds

We intend with effect from 1 June 2022 to start undertaking stock lending within the Vehicles. This is already allowed in the Vehicles, but thus far, we have not used this.

We intend to enter into stock lending to align with the other funds offered by abrdn. Stock lending may generate additional return for the funds, which can help to improve performance and may lower a fund's overall costs. Stock lending is a common feature in active investment management.

When a fund engages in stock lending it will be exposed to a number of risks including credit and legal risk in the event of a default by a borrower failing to return the borrowed stock; these risks are identified, managed and mitigated as part of our Risk Management Policy which includes the fund being indemnified and a collateral management programme ensuring any loan stock is fully covered.

Further information on stock lending is contained in the prospectus documents, which will be updated on 1 June 2022, which you can find on our website www.abrdn.com.
