Notice to shareholders of Bellevue Funds (Lux) - BB Adamant Asia Pacific Healthcare (the Sub-fund)

Dear shareholder,

We would like to inform you that the prospectus of the Company (the **Prospectus**) has been amended. The amendments include the following:

- Amendment of the name of the Sub-fund to "Bellevue Asia Pacific Healthcare".
 After the successful sale of Bank am Bellevue (BB) in 2020, Bellevue Group has been transformed to a pure play asset manager. As a consequence the brand "Bellevue" is now embedded in the name of all its investment funds.
- 2. Increase of the Sub-fund's investment limit for China A-shares from 20% to 35%.
- 3. Inclusion of a disclosure in relation to outsourcing and data transfer by RBC Investor Services Bank S.A. has been included in the general section of the Prospectus.

The amendments are considered material and you may redeem your shares free of charge during a 30 day period starting on 30.9.2021 and ending on 31.10.2021. If shareholders have any questions about the above changes, they should consult with their current contact at their broker.
