We would like to draw your attention to changes that we are planning to make to the Capital International Fund (CIF) prospectus. All changes will become effective on or around 1 July 2022 when the new prospectus will enter into force. This prospectus will then be available on our website. Meanwhile, you can obtain the revised prospectus incorporating the changes upon request and free of charge from the registered office of CIF, or ask any queries using the contact details provided in the table on the last page of this notice.

This letter is purely for notification purposes and no action is required on your part if you agree with the changes.

Capital Group European Opportunities (LUX) and Capital Group European Growth and Income Fund (LUX)

The existing investment guideline of Capital Group European Opportunities (LUX) and Capital Group European Growth and Income Fund (LUX) referring to the primary investment universe has been amended to include Switzerland. With effect from 1 July 2022, at least 75% of the assets of these funds will be invested in issuers domiciled in the EEA, EU, UK and Switzerland. This amendment to an existing guideline has been made to align investment guidelines with the appropriate investment opportunity set for European Equity Funds.

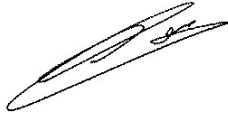
The Fund will keep the same investment objective, investment team, and its risk profile will not be affected.

Prior to the effective date of all the above listed changes, you may redeem your shares in Capital Group European Opportunities (LUX) and Capital Group European Growth and Income Fund (LUX) as usual, without redemption charges. No action is required on your part if you agree with the changes listed above.
