## United Kingdom leaves the European Union ("Brexit")

On 31 January 2020, the United Kingdom (UK) withdrew its membership of the European Union (EU) and is now in an 11-month transition period which comes to an end on 31 December 2020.

With effect from 1 January 2021, UK domiciled investment funds that had previously operated under the Undertakings for the Collective Investment in Transferable Securities (UCITS) regulations will cease to be classed as UCITS and will instead become "UK UCITS". From the same date, UK domiciled Non-UCITS Retail Schemes (NURS) will cease to be classed as EU Alternative Investment Funds (AIFs) and instead will be classed as third country AIFs.

Any UK domiciled Janus Henderson funds that were registered for marketing purposes in any EU 27 countries will no longer be registered and marketing of the funds will therefore cease. For the avoidance of doubt our "UK UCITS" and NURS will not be registered for marketing in the EU as third country AIFs.

We do not require you to take any action regarding your investment. The way in which the funds are managed will not be impacted by this. We are not making any changes to the investment policy or objectives, and your fund manager continues to manage your fund in the same way.

Statement for Spanish resident investors

Please note that from 1 January 2021, Janus Henderson UK domiciled funds will not be registered for marketing in Spain. If you are an investor who benefits from the Spanish tax deferral regime for the transfer of UCITS, please note this regime will no longer be applicable from that date.
