## Temporary suspension in dealing of the Liontrust Russia Fund

We are writing to tell you that dealing in the Liontrust Russia Fund has been suspended. This means that investors have not been able to make purchases or redemptions in the Fund from 12pm on 25 February 2022 until further notice.

Any purchases or redemptions that were received after 12pm on Friday 25 February have been cancelled and they will have to be resubmitted when dealing in the Fund resumes.

Liontrust has not taken this action lightly and we appreciate this is disappointing news for you as an investor. We want to assure you that we explored every alternative option possible to avoid a suspension of dealing in the Fund.

In the end, Liontrust decided that suspending dealing was in the best interests of all investors given the exceptional circumstances in terms of the Russian invasion of Ukraine and the sanctions imposed on and by Russia as a result.

While Liontrust has been able to continue to price the Fund on a daily basis – which is available on our website at <a href="www.liontrust.co.uk/funds/russia-fund">www.liontrust.co.uk/funds/russia-fund</a> - the closure of the Moscow stock exchange on Monday 28 February and the temporary ban on foreign investors trading in local Russian securities prevented the Fund from trading normally in its underlying investments.

Liontrust' decision to suspend dealing was made with the agreement of the Fund's Depositary.

At the moment, we are not able to tell you for how long dealing in the Russia Fund will be suspended. Liontrust will keep the suspension under continual review given it is such a rapidly changing situation and we will ensure the suspension only continues for as long as it is justified to meet the interests of all investors.
