Background

We are writing to you in your capacity as a Unitholder of the Sub-Fund to notify you of forthcoming changes relating to your Units, as described below.

Change to Maximum Subscription Fee

With effect from on or around 18 July 2022 (the "Effective Date"), the maximum subscription fee applicable in respect of certain Units will be changed as indicated in Schedule 1.

Change to Dealing Deadline

The current Dealing Deadline for redemptions is: 4 p.m. (Irish time) four (4) Business Days prior to the relevant Dealing Day.

With effect from the Effective Date, the Dealing Deadline for redemptions will be changed to: 4 p.m. (Irish time) one (1) Business Day prior to the relevant Dealing Day.

The settlement timeframe of such trade requests remains within three (3) Business Days of the relevant Dealing Day. The Dealing Deadline for subscriptions remains unchanged.
