We are writing to you in your capacity as a Shareholder in one or more of the Portfolios, which are sub-funds of the Company. The purpose of this circular is to notify you of changes to each of the Portfolios, which will be reflected in a revised version of the supplement for the Portfolios, which is expected to be noted by the Central Bank on or about 6 January 2021.

Unless otherwise indicated, all capitalised terms shall have the same meaning as otherwise described in the Company's prospectus dated 16 September 2020 (the "**Prospectus**") and in the supplement for the Portfolios dated 16 September 2020 (the "**Supplement**").

**Changes to the Portfolios**

It is intended to update the types of fixed income securities in which the Portfolios currently invest to include an ability to invest in contingent convertible bonds ("**CoCos**"), subject to a limit of 10% of the Portfolio's net asset value. It is not expected that providing for the ability to invest in CoCos will significantly alter the credit quality, borrowing or leverage limits or risk profile of the Portfolios. The Directors believe that these changes are in the best interests of the Shareholders of the Portfolios.
