We are writing to inform you of the following changes to your Fund's prospectus (the "Prospectus"):

Taxonomy Regulation

The Prospectus was updated to reflect the Regulation (EU) 2020/852 of the European Parliament and of the Council of 18 June 2020 on the establishment of a framework to facilitate sustainable investment, and amending Regulation (EU) 2019/2088 (the "Taxonomy Regulation") seeks to establish a framework to facilitate sustainable investing and a criteria for determining whether an economic activity qualifies as environmentally sustainable.

Performance Fee

The Prospectus was updated to reflect the European Securities and Market Authority (the "ESMA") Guidelines on performance fees in UCITS and certain types of AIFs, ESMA 34-39-992, of 5 November 2020.

Central Administration Agent

The references to the Management Company, FundRock Management Company S.A., acting as a Central Administration Agent, have been removed for clarification purposes. There is no change in the role of the Management Company and European Fund Administration S.A. continues acting as administration agent and registrar and transfer agent of the Fund under the oversight of the Management Company.

Miscellaneous

Clarifications on legal risk associated with Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability related disclosures in the financial services sector (the "SFDR") and Taxonomy Regulation, ESG Data reliance, relative performance of ESG Fund and the sustainable finance disclosures have been provided.
