Prior to that he worked as a researcher on operations research at the Technical University of Chemnitz, Germany.

He holds a master's degree in Physics from the University of Heidelberg, Germany, and received a PhD in 1993. Rainer has been a Certified Financial Risk Manager (FRM) since 2005.
