Dear Shareholder

Change to the risk profile of Fidelity Funds – Sterling Bond Fund and Fidelity Funds - US Dollar Bond Fund

The Board of Directors of Fidelity Funds (the "Board") constantly reviews its product range to ensure they are presented to investors in a clear and fair way. The level of volatility that investors should expect in the bond market has increased in the past few years and the Board believes a fairer reflection of the risk profile of Fidelity Funds - Sterling Bond Fund and Fidelity Funds - US Dollar Bond Fund (the "Funds") is now 'low to medium risk'.

The change is designed to provide greater clarification of the risk profile of the Funds which we believe will benefit Shareholders when making their investment decisions. **It is important to emphasise that there is no change to the investment objective of the Funds and the change to the risk profile does not entail any change in the manner in which the funds are managed.**

With immediate effect the following change will be made to the risk profile of the Funds:

From: "Low risk"

To: "Low – medium risk (bond)"

Next steps

You do not need to take any action, as this change will come into effect immediately.

The Board accepts full responsibility for the accuracy of the information contained in this letter and confirms, having made all reasonable enquiries that to the best of its knowledge and belief there are no other facts the omission of which would make any statement herein misleading.
