Dear Shareholder

Important information about your investments in BlackRock Global Index Funds (the "Fund")

The directors of the Fund wish to advise you that the names of the sub-funds of the Fund (the "Sub-Fund(s)") listed in the attached Appendix will be changing on or around **29 August 2017** (the "Effective Date"). You are being contacted because you are invested in one or more of the affected Sub-Funds.

Rationale for re-brand

BlackRock is committed to the continuous enhancement of its product suite. BlackRock's iShares brand has long been associated with BlackRock's exchange traded fund ranges which utilise indices in their investment strategy, however, it has now been decided to extend the use of the iShares brand to also cover our range of index mutual funds. On or around the Effective Date, a number of BlackRock index mutual fund ranges will be renamed with the iShares brand. The renaming seeks to bring greater clarity to our full suite of index solutions that investors can use to build stronger, more efficient, investment portfolios.

The purpose of this notice is to communicate to investors that the key change for the Sub-Funds listed in the Appendix will be their re-naming with BlackRock's iShares brand. The name of the Fund umbrella as stated in the prospectus, which incorporates general information about the Fund overall, will not change and will retain its current name of "BlackRock Global Index Funds".

In addition to the change from BlackRock to the iShares branding, each Sub-Fund name will also include a geographic indicator to highlight where the fund is domiciled. The indicator "(LU)" has been included in each Sub-Fund name to clearly indicate each Sub-Fund's Luxembourg domicile and to ensure that the Sub-Funds within the Luxembourg index fund ranges may be easily distinguished from other index funds or sub-funds, which may have a similar name.

An amendment to the prospectus of the Fund reflecting the changes set out in this letter will be published on or around the Effective Date. The Fund documents will be available, along with all information on the Sub-Funds, in the same way as before, including through the Sub-Funds' profile pages on www.blackrock.com and, from the Effective Date, also on www.iShares.com.

Action to be taken by you

You are not required to take any action in respect of your investment regarding the changes outlined in this letter. **The change will not impact the manner in which the Sub-Funds are managed, their operations or cost.** However, certain markets may impose temporary trading restrictions and/or suspensions in respect of a name change according to local sub-custodian procedures. BlackRock (Luxembourg) S.A. will continue to be the management company.

Costs

The cost of this letter, the re-branding and any updates to documentation relating to the Sub-Funds to reflect the matters detailed in this letter will be borne by BlackRock. You, as an investor, will not bear any cost.
