Dear Investor

Franklin Templeton Funds - Making Your Clients' Investment With Us Cheaper

This letter contains important information about your clients' investment with us.

As you will be aware, the Financial Conduct Authority (FCA), has introduced guidance that gives nominees the authority to move shareholders into a cheaper share class within the same fund where they believe it to be in the shareholders' best interests.

According to our records, you have client(s) invested in our A share class. Subject to what you have agreed with your clients in relation to rebating (if and where applicable), it may be in their best interests to convert their investment from the more expensive A share class into an alternative, cheaper share class. The alternative share classes available are the W and the Z share classes, which are available to different types of investors. FTF will not make any charge to make the conversion from A to W or Z shares within the same fund and there will be no change to how your clients' investment is managed.

Please see below a summary of the difference between the A share class and the alternative, cheaper W and Z share classes. The annual management charges for the share classes of the FTF funds are enclosed in Appendix 1:

Share Class	Description			
A	A share classes include charges for administrative services and fund management as well as the payment of intermediary commission. They are the most expensive share classes within FTF.			
W	W share classes are available to certain large distributors and platforms having separate fee arrangements with their clients who at our discretion are considered wholesale investors providing services to other investors. The charges for these share classes include provision for administrative services and fund management, but do not include any provision for commission to intermediaries. There is no initial charge. These share classes have lower charges than the A share classes and provide the same shareholder rights.			
Z	Z share classes are available to any shareholder who invests directly with us, with or without the assistance of an intermediary such as a financial adviser. Such shares may be held in the name of the shareholder or the intermediary. The charges for these share classes include provision for administrative services and fund management, but do not include any provision for commission to intermediaries. There is no initial			

charge. These share classes have lower charges than the A share classes and provide the same shareholder rights.

If your clients hold investments with us in their own name and wish to convert their shares into the Z share class, please could you arrange for them to send a signed instruction form to us at the address below:
